PUBLIC COMMENT PERIOD

Luke Jensen, 45 Sylvan Avenue, suggested that the City Council accept the County settlement offer on the pending lawsuit. He noted the County has spent \$150,000 fighting the suit over a value of benefits of approximately \$100,000. He said the settlement offered was fair and should be accepted. Charles Soule of 135 Bartlett Street said he wants the Council to hire the next Police Chief from outside of the Department and he wants them to hire a female. He wants the Department to be an open police department and hiring from the outside would accomplish this.

She also noted there is a potential buyer lined up for this property. She requested additional time to

With regard to the property at 148 Bartlett Street, to adopt the Findings of Fact, Conclusions of Law and Order of Demolition proposed by the City Planning and Code Enforcement Department, which Order establishes the corrective action to be taken by the property owner and the time frame for taking such action, and which authorizes the City Administrator to take such corrective action if the property owner fails to do so, and to recoup the City's costs through a special tax or collective action. STREET ACCEPTANCE FOR CORTLAND WAY AND A PORTION OF VISTA BELLA DRIVE

ORDER AUTHORIZING THE MAYOR TO EXECUTE AMENDMENT NUMBER 6 TO THE EMPLOYMENT AGREEMENT BETWEEN THE CITY OF LEWISTON AND EDWARD A. BARRETT

Councilor Lachance said he would consider this increase next year but feels the current compensation is right in line with other towns at present. Councilor Lajoie spoke in favor of the increase noting compared to the private sector, this salary is well below a similar position in a company with the same number of employees and same operating budget.

Whereas, the City entered into an agreement with Edward A. Barrett on December 1, 2009 under which he assumed the position of City Administrator; and

Whereas, the Council wishes to adjust the Administrator's salary by 2.0% effective as of payroll checks dated July 6, 2016, the same increase provided to other non-represented employees of the City;

Now, therefore, be It Ordered by the City Council of the City of Lewiston that the Mayor is authorized to execute a sixth amendment to the employment agreement with Edward A. Barrett, a copy of which is attached hereto.
